Sept 14th Trial Bexleyheath round 7: This took place at Knowle Farm, Heathfield and the Stewards report was read out, 51 riders, 3 laps of 13 sections, event started on time riders dispatched en-bloc to 3 different sections, all observers and officials present, a very well organized event with sections to NKTC standard, riders spoken to said it was a very good trial, well done Bexleyheath. Comment from those present and from the riders' survey confirmed this.
